



2019-2020 TUITION INSTALLMENT PAYMENT PLAN

(Two Payment Plan)

The tuition for the 2019-2020 WeROCK training program includes weekly training and coaching sessions, a WeROCK training Tech-top, a basic WeROCK uniform, monthly nutrition & sports clinics, and ALL race entrance fees. Tuition paid is non-refundable, and all full tuition payments include a \$300 tax-deductible* donation to the WeROCK general fund.

Tuition may be broken up into two equal payments, as follows:

1. An initial payment of \$425, due no later than September 28, 2019 (or the day you join if after this date)
2. A second payment of \$425, due no later than February 1, 2020

Payments should be made by check and given to your child's coach. Out-of the area Sponsorship payments can be made by mail using the *Sponsorship Donation Receipt* form. Our mailing address for Sponsorship payments is 30 Mulholland Court, Mission Viejo, CA 92692.

Delinquent Payments

Payments must be received by the due dates specified above. If any installment payment is not received by the payment due date, all services, including, but not limited to race participation, practices and special events may be withheld by WeROCK until the amount due is paid in full.

WeROCK makes every effort to keep student costs to a minimum, and delinquent payments place a financial burden on the organization. If any payment is not received by the payment due date, the signer may be subject to a \$25.00 late fee for each delinquent payment and authorizes WeROCK to pursue collection activities to collect any past due amounts. Such activities may include referral of the agreed-upon payment to a collection agency and/or to a credit bureau organization and the release of information concerning the past-due account, when necessary, to collect the delinquent payment. Signer further agrees to pay reasonable collection charges, including any court costs and attorney's fees.

Financial Assistance

Signer understands and agrees that funds received from any types of financial assistance, including Scholarships, Sponsorships, or fundraising activities, do not cancel the installment payment obligation. Financial assistance payments are credited towards the outstanding tuition balance, to reduce the total owed, and are not considered a substitute for regularly scheduled payments.
